1. Wedding Photography Booking/Order

- 1.1 The wedding photography services ordered are as detailed on this Wedding Booking Form and at the agreed costs as detailed on the same.
- 1.2 Any variation to the wedding photography services listed, can only be made in writing and agreed by both Bloomwood Photography and the Bride/Groom.
- 1.3 To complete a booking and confirm a reservation for wedding photography this form must be complete and returned back to Bloomwood Photography, along with a deposit payment as prescribed.

2. Payment

- 2.1 A non-refundable booking fee/deposit is payable when the client signs this contract, as prescribed and advised in advance by Bloomwood Photography.
- 2.2 The balance of payment between the deposit and the Total Cost is due for payment at least 4 weeks before the wedding day.

3. Special Requests/Coverage

- 3.1 The client understands and accepts that the photographic coverage will be as the photographer's professional expertise determines and that no one photograph will be deemed more important than another.
- 3.2 Bloomwood Photography will make every effort to satisfy any special requests made by the Client, but they are not a binding instruction, and guarantee to be provided by Bloomwood Photography.
- 3.3 The ability for photographs in venues such as churches or registry offices may be restricted, and is dependent upon whether permission is granted by those venues for photography. Bloomwood Photography will endeavour to clarify and seek permission where possible, but can take no liability where photography is prohibited.

4. The Photographer

4.1 On occasions, and potentially without notice, it may be necessary for the photographer originally specified to be substituted for another photographer (e.g. due to ill health).

8. Digital Files

8.1 The ownership of any digital files remain the property of Bloomwood Photography.

9. Licence

9.1 Bloomwood Photography shall be granted complete artistic licence including in relation to the poses photographed and the locations used. The photographer(s) judgement regarding the locations, poses and number of images taken shall be final. Due to the vagaries of weather and the willingness of subjects it may not be possible to capture all the images requested.

10. Force Majeure or Act of God

10.1 The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

11. Previews

- 11.1 Although Bloomwood Photography will do its best to produce more proofs/preview images than discussed with the client, there is no guarantee that any particular number of proofs/preview prints will be produced.
- 11.2 Bloomwood Photography will make all final images available to the client before publishing photographs for general viewing, subject to the clients' express permission to the contrary.
